The planned acquisition marks the next step in Flender's growth strategy after progressing into independence last year. The 22 GW of Moventas installed base, service know-how and multi-brand capabilities will be the lever for further growth in Winergy service business resulting in a comprehensive one stop service solution for Wind customers. The Moventas global production and service network adds an additional three gigawatts wind gearbox assembly capacities, next to extensive capabilities in field services as well as gear manufacturing.
